FEDERAL SELECT AGENT PROGRAM 2022 ANNUAL REPORT | KEY STATISTICS

The 2022 Annual Report of the Federal Select Agent Program (FSAP) provides insight into the program's regulatory activities and includes a look at compliance with the select agent regulations at laboratories across the nation. The report also highlights FSAP's efforts to engage with the regulated community throughout the year to enhance regulatory compliance. The content underscores that overall, laboratories registered with the program are compliant with the regulations, and none of the small number of reported incidents during the year resulted in a significant risk to public health or agriculture. The publication, now in its eighth year, reflects the program's ongoing commitment to transparency.

BACKGROUND

FSAP is managed jointly by the Centers for Disease Control and Prevention and the Animal and Plant Health Inspection Service. The program regulates the possession, use, and transfer of biological select agents and toxins – which are materials that have the potential to pose a severe threat to public, animal or plant health, or to animal or plant products – so that important work with dangerous and deadly pathogens can be conducted as safely and securely as possible.
